Dear Ms. Tadlock,

I was referred to you as the person to contact in regard to an appeal for the late fee of \$400 charged to our credit card when my husband filed the annual report. I am praying that you can assist us in this matter and credit our account. Capital One is aware that I am making the appeal.

I am usually the one who files any paperwork regarding our business. This year I remembered it was usually due in May and asked my husband to file. I cannot find any paperwork that was received in regard to informing us of the due date. He completed the filing on line and handed me the receipt. I just filed it away and had no idea the amount was for \$538.75 until I received my Capital One bill. I was dumbfounded and thought it was a mistake or that he had done something wrong as I was expecting a \$55.00 charge. I then looked at the receipt and saw the amount, still believing something had been entered wrong. I called the Division of Corporations and learned that not only had the fee more than doubled but there was a \$400 late fee! We simply cannot afford this fee of \$400. Every month we are putting \$500 to \$1000 into the business from our personal funds just to cover fixed expenses. It is a small hauling business and ever since the multiple hurricanes there has been increased competition. My husband works a full time job and tries to do it on the side. He is also in remission from prostate cancer and does not have the strength and drive that he once did. We have quit advertising in the newspaper as we could not afford that additional expense. We are closing down the business in December of this year and therefore will also not be applying to renew our fictitious name again. It has been a very costly financial experience for us, although he loved driving the big truck when he was healthier. It is now broke down and not usable.

We would sincerely appreciate any consideration you can give this matter and are hoping it is resolved in our favor. If I had done the re-application on line and/or realized there would be a \$400 late fee I would not have renewed the LLC and would have shut down the business at that time rather than wait until December. Or, if possible, please credit our account for the whole amount and I will shut it down immediately.
