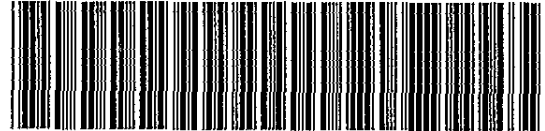

ARTICLES OF ORGANIZATION
OF
TIKI ON THE BAY RESORT CONDOMINIUM DEVELOPERS, LLC

The undersigned members, for the purpose of forming a Limited Liability Company for profit under the laws of the State of Florida, hereby adopt the following Articles of Organization:

ARTICLE I - NAME

The name of this Limited Liability Company is:

TIKI ON THE BAY RESORT CONDOMINIUM DEVELOPERS, LLC

ARTICLE II - TERM OF EXISTENCE

This Limited Liability Company is to exist perpetually.

ARTICLE III - PURPOSES

The purposes of this Limited Liability Company are to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - PRINCIPAL OFFICE

The principal place of business and mailing address of this Limited Liability Company shall be 6583 Midnight Pass Road, Sarasota, Florida 34242.

ARTICLE V - INITIAL REGISTERED AGENT AND ADDRESS

The street address of the registered office of this Limited Liability Company is 6583 Midnight Pass Road, Sarasota, Florida 34242 and the registered agent at such office is Warren D. Hickernell, Jr.

ARTICLE VI - MANAGEMENT

This Limited Liability Company shall be managed by a manager selected by a majority vote of its members.

ARTICLE VII - VOTING

All members shall be entitled to vote on matters relating to the business operations of this Limited Liability Company. Each member shall have one vote per membership unit owned.

ARTICLE VIII - MEMBERSHIP UNITS

The number of membership units that this Limited Liability Company is authorized to have outstanding at any one time is ONE HUNDRED THOUSAND (100,000) voting units having a no par value.

ARTICLE IX - ADDITIONAL MEMBERS

No person may be admitted as a member of this Limited Liability Company unless each existing member consents in writing to the admission of such additional member.

ARTICLE X - CONTINUATION OF BUSINESS OPERATIONS

In the event of the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member, the remaining members shall continue the business operations of this Limited Liability Company.

ARTICLE XI - AMENDMENT


These Articles of Organization may be amended in certain instances by the members as provided by statute.
