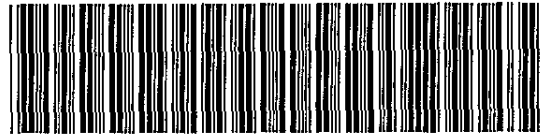

FOURTH: The mailing address and street address of the principal office of the Limited Liability Company is 10438 Point view Ct., Orlando, FL 32836.

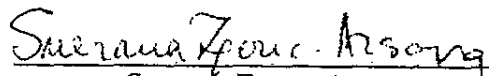

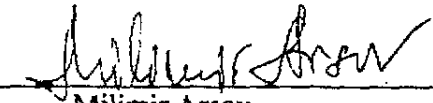
