

**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608 and F.S. Chapter 621, Professional Service Limited Liability Company, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I
NAME**


ARTICLE V
