**ARTICLES OF ORGANIZATION OF
OLYMPIA, LLC**

ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this limited liability company shall be OLYMPIA, LLC and the mailing address and street address of its principal office shall be 11983 North Tamiami Trail, Suite #132, Naples, Florida 34110, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE II

PURPOSES AND POWERS

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business on unanimous consent of the remaining members.

ARTICLE V

DURATION

This limited liability company shall exist perpetually or until dissolved in a manner provided by law, or as provided in the operating agreement adopted by the members and shall commence its existence on filing of these Articles.

AMENDMENT

These articles may be amended by a vote of a majority in interest of the members.
