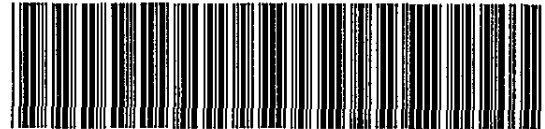

The name of the limited liability company is CHARLOTTE COUNTY TITLE & ABSTRACT, LLC(the "Company").




