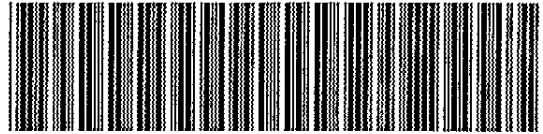

The undersigned being authorized to execute and file these articles hereby certifies that:

ARTICLE I - Name

ARTICLE IX - Admission of Additional Members


Additional Members will be admitted only upon the consent of the Members owning a majority of the Membership Units upon such terms as provided in the Regulations.
