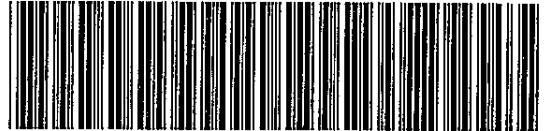



The mailing address and street address of the principal office of the Company is 21216 Harbor Way, Miami, Florida 33180.


ARTICLE III - Registered Agent and Office
