### CERTIFICATE OF AMENDMENT TO THE ARTICLES OF ORGANIZATION FOR THE PALMS AT FOREST HILLS, LLC

(A Florida Limited Liability Company)

**FIRST:** The name of the limited liability company is The Palms at Forest Hills, LLC (also called the "**Company**").

**SECOND:** The Articles of Organization of the Company were originally filed with the Florida Division of Corporations on May 22, 2003.

**THIRD:** The Articles of Organization are hereby amended as set forth below:

#### ARTICLE VIII - PURPOSE

The purpose of the Company is to engage in any lawful act, business or activity for which limited liability companies may be organized under the Florida Act, and to engage in any and all activities necessary or incidental thereto. This may include without limitation the following:

- (a) to acquire, own, hold, lease, operate, manage, maintain, develop and improve certain real property, specifically the Property, as more fully described in the applicable loan documents relating to the Property including the applicable notes, deeds of trust, assignments of leases and rents, security agreements, and other documents evidencing such loans and any refinancings thereof (collectively, the "Loan Documents");

- (c) to sell, transfer, service, convey, dispose of, pledge, assign, borrow money against, finance, refinance or otherwise deal with the Property to the extent permitted under the respective Loan Documents; and
- (d) to engage in any lawful act or activity and to exercise any powers permitted to limited liability companies organized under the laws of the State of Florida that are related or incidental to and necessary, convenient or advisable for the accomplishment of the above mentioned purposes.
