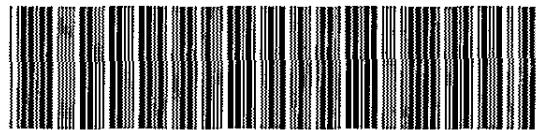

**ARTICLES OF ORGANIZATION
OF

(A Florida Limited Liability Company)
Pursuant to Section 608.407 of the Florida Statute**

First: The name of the limited liability company is: **ELDANA COMMERCE LTD. CO.**


