## **ARTICLES OF ORGANIZATION OF COMMUNITY MORTGAGE OF FLORIDA, LLC**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies as follows:

### **ARTICLE I**

#### **NAME**

### **DESIGNATION OF REGISTERED OFFICE AND REGISTERED AGENT**

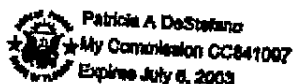


