

The following plan of merger, which was adopted and approved by each party to the merger in accordance with section(s) 607.1107, 617.1103, 608.4381, and/or 620.202, is being submitted in accordance with section(s) 607.1108, 608.438, and/or 620.201, Florida Statutes.

FIRST: The exact name and jurisdiction of each **merging** party are as follows:

If at any time after the Effective Date, Ocean Drive Management & Consulting, LLC shall determine that any further conveyances, agreements, documents, instruments and assurances or any further action is necessary or desirable to carry out the provisions of this Plan, the appropriate members of Ocean Drive Management & Consulting, LLC or officers of Ocean Drive Management & Consulting, Inc., as the case may be, whether past or remaining in office, shall execute and deliver on the request of Ocean Drive Management & Consulting, LLC, any and all proper conveyances, agreements, documents, instruments and assurances and perform all necessary or proper acts, to vest, perfect, confirm or record such title thereto in Ocean Drive Management & Consulting, LLC, or otherwise carry out the provisions of this Plan.

- D. On the closing, as provided in this Plan, Ocean Drive Management & Consulting, Inc. and Ocean Drive Management & Consulting, LLC, shall cause their respective members and officers to execute Articles of Merger and on such execution this Plan shall be incorporated by reference into the Articles of Merger as if fully set forth in such Articles and shall become an exhibit to such Articles of Merger.
