**ARTICLES OF ORGANIZATION
OF
JRH ENGINEERING, P.L.C.**

The undersigned, for the purpose of forming a professional limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, and the Professional Service Corporation and Limited Liability Company Act under F.S. Chapter 621, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME AND SERVICES

The name of the professional limited liability company shall be **JRH Engineering, P.L.C.** The company is an engineering firm which shall provide engineering services.

ARTICLE II - ADDRESS

The mailing address of the principal office of the company is **9205 S. Indian River Drive, Ft. Pierce, Florida 34982**, and the street address is **9205 S. Indian River Drive, Ft. Pierce, Florida 34982**.

ARTICLE III - DURATION

The company shall commence its existence on the date these Articles are filed and shall operate for a period of thirty years.

ARTICLE IV - REGISTERED OFFICE AND AGENT

ARTICLE V - CAPITAL CONTRIBUTIONS

The members of the company shall contribute to the capital of the company cash in the amount of Five Hundred Dollars (\$500.00).

ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members, or as provided in the regulations.

ARTICLE VII - ADMISSION OF NEW MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her

interest in the company as set forth in the regulations of the company, but the transferee shall have a right to participate in the management of the business and affairs of the company or become a member unless all of the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent. Members must be duly licensed or otherwise legally authorized to render the same professional service as the professional limited liability company.

ARTICLE VIII - MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or in the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by vote of all the remaining members.

ARTICLE IX - MANAGEMENT

The company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 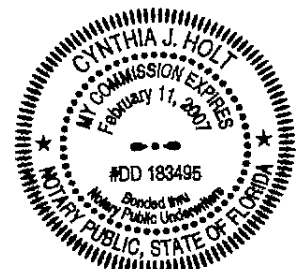

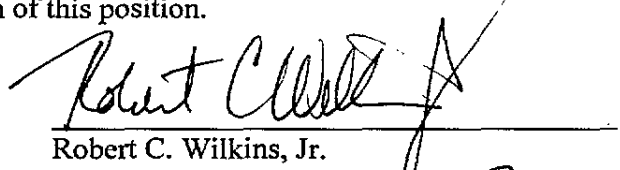

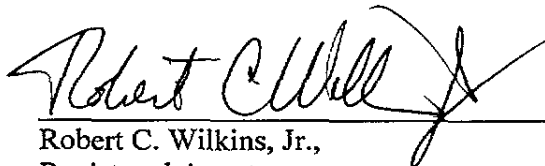
