# ARTICLES OF ORGANIZATION FOR VALHALLA REAL ESTATE HOLDINGS, L.L.C.

#### **ARTICLE 1 - NAME**

The name of the Limited Liability Company is VALHALLA REAL ESTATE HOLDINGS, L.L.C.

The number of members of the board of managers may be either increased or diminished from time to time as provided in the Regulations of the Limited Liability Company but shall never be less than one (1). Each manager shall serve until the first annual meeting of the members of the Limited Liability Company or until their successors are elected and qualify. ### ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS 3000200702 6)))

### **ARTICLE VIII - WITHDRAWAL**

The Members of the Limited Liability Company shall have the right to withdraw as a member with (i) six (6) months prior notice, and (ii) with the unanimous consent of all the members.

### **ARTICLE IX - DISTRIBUTION**


