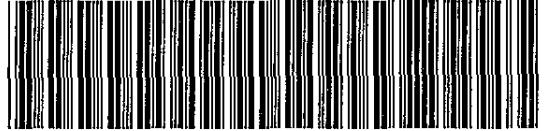

ARTICLE I: Name

The name of the limited liability company shall be TAMPA PARTNERS PROPERTIES, LLC.

ARTICLE II: Address and Place of Business

The mailing address and principal place of business for the limited liability company shall be:

ARTICLE III: Period of Duration

The limited liability company shall begin existence on the day of filing and shall continue into perpetuity or until dissolved in a manner provided by law or by regulations adopted by the Member(s) of the limited liability company.

ARTICLE V: Registered Office and Registered Agent

Neil S. Schecht is specifically authorized to sign and file such Affidavits as may be required under Section 608.407, Florida Statutes.

ARTICLE VI: Management

The limited liability company is to be managed by one manager or more managers and is, therefore, a manager - managed company.

ARTICLE VII: Continuity of Business

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or upon the occurrence of any other event which terminates the continued membership of a member in the limited liability company, the business of the limited liability company shall not cease and the limited liability company shall not be dissolved unless the business of the limited liability company is terminated by the consent and agreement of remaining Members.

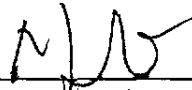
ARTICLE VIII: Operating Agreement

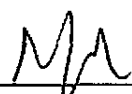
