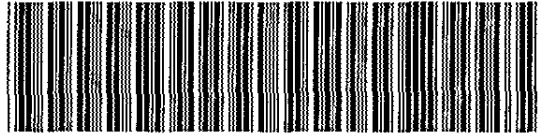

ARTICLES OF ORGANIZATION

FOR

S. & P. N. B., LLC

The undersigned subscribers to these Articles of Organization, being natural persons competent to contract, hereby execute this document for the purpose of becoming a limited liability company under the laws of the State of Florida.

ARTICLE I: NAME

The name of this limited liability company shall be:

S. & P. N. B., LLC

ARTICLE II: ADDRESS

The principal place of business of this limited liability company shall be 5460 Apalachee Parkway, Tallahassee, Florida 32311, but it shall have the power to transact business in any other place or places both within and without the State of Florida and throughout the world. The mailing address of the limited liability company shall be 700 Medallion Way, Tallahassee, Florida 32317.

ARTICLE III: MEMBERS/MEMBER MANAGEMENT

There shall initially be three (3) members of this limited liability company:

- 1) Sidney E. Gray (Managing Member);
- 2) Paul and Lorna Osterbye, husband wife, whose membership shall be held in tenancy by the entireties (Managing Member); and

3) Angler's Harbor, Inc., a Florida corporation (Non-Managing Member).

New members may be added in the future in accordance with Section 608.4232 (*Florida Statutes 2002*). All members shall be designated as either managing members or non-managing members. Managing members shall be entitled to vote. Non-managing members will have no voting rights or ability to direct or manage the limited liability company. Non-managing members shall have no authority to legally bind the limited liability company, or transfer any asset of the limited liability company. Third parties are hereby put on notice of the limitations of non-managing members. Each managing member shall be entitled to one vote. Any membership held in tenancy by the entireties is entitled to one vote. Either spouse may vote for the united membership. Either spouse may bind the limited liability company. Sidney E. Gray shall be a single managing member, entitled to one vote. Paul and Lorna Osterbye, husband and wife, shall be a single managing member, entitled to one vote. Angler's Harbor, Inc. is a non-managing member, and has no voting authority or right, and no legal authority to bind the limited liability company.
