FOR

KMJ PROPERTIES, LLC

ARTICLE I - Name

The name of this limited liability company shall be KMJ PROPERTIES, LLC.

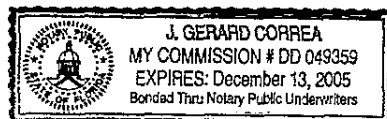
