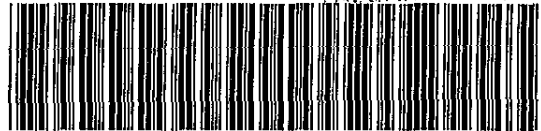

The Limited Liability Company shall indemnify any officer or member, or any former officer or member, to the full extent permitted by law.

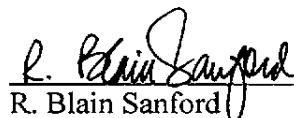
ARTICLE 9: OPERATING AGREEMENT
