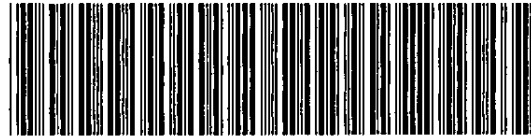

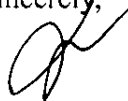

3. The date of Dissolution was approved March 15, 2012.

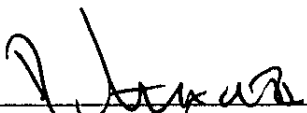
