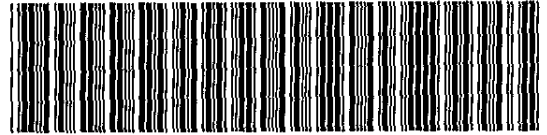

## **ARTICLES OF ORGANIZATION**

### **ARTICLE I – Name**
