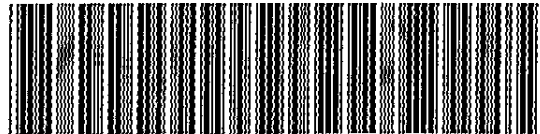

The Company is a manager-managed company. The terms of the Company's management are set forth in the Operating Agreement of the Company.


