

ARTICLES OF ORGANIZATION FOR A FLORIDA LIMITED
LIABILITY COMPANY FILED PURSUANT TO THE AUTHORITY
OF FLORIDA STATUTES, CHAPTER 608

The undersigned, for the express business purposes for
forming a Florida Limited Liability Company under Chapter
608 of the Florida Statues, and with the express authority of
all named members of this Florida Limited Liability Company,
hereby respectfully submitted these instant Articles of

ARTICLE 1. NAME

ARTICLE 3. DURUATION

The period of duration of 305 Motoring of Miami, L.L.C. shall be perpetual.

ARTICLE 4. MANAGEMENT RESERVED TO ONLY NAMED MEMBERS


