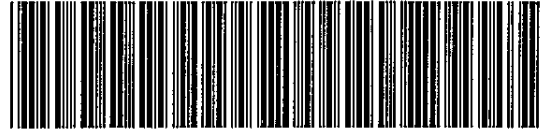

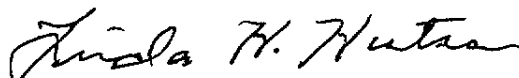

ARTICLE I. NAME

The name of the Limited Liability Company ("Company") is RE/VEST, L.L.C.

ARTICLE II. PURPOSE

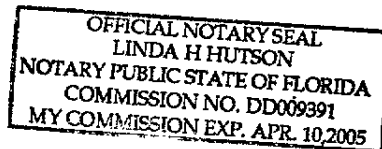
