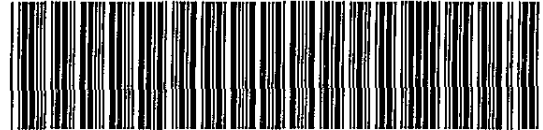



Article VI. Purposes. The limited liability company may engage in any or all lawful business, purpose or activity, whether or not engaged in for profit, for which limited liability companies may be organized under the Florida Limited Liability Company Act.




