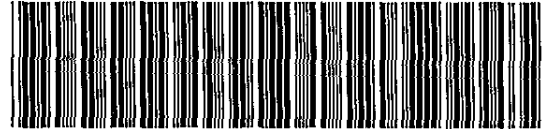

ARTICLE I: The name of the limited liability company shall be Parachute Bend, LLC (the "LLC").




