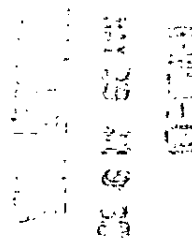

ARTICLE V. POWER AND AUTHORITY


The Limited Liability Company shall have all the rights and powers now or hereafter conferred on Limited Liability Companies by the laws of the State of Florida.
