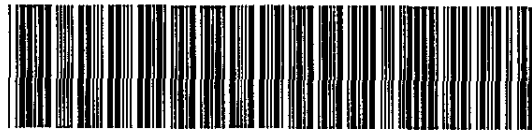

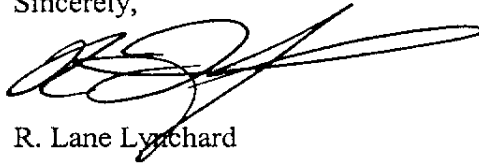

**ARTICLES OF ORGANIZATION
OF
BAY TO GULF PROPERTIES, L.L.C.**

The undersigned, being authorized to execute and file these Articles on behalf of the members for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby certify and adopt these Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be **BAY TO GULF PROPERTIES, L.L.C.**

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company shall be **5512 East Longboat Blvd., Tampa, Florida 33615.**

ARTICLE III - DURATION

The Company shall commence on the date of filing these Articles of Organization with the Florida Department of State and the Company's existence shall be perpetual.

ARTICLE IV - REGISTERED AGENT

ARTICLE V - ADMISSION OF ADDITIONAL MEMBERS

Members of the Company have the right to admit new members. ARTICLE VI - MEMBERS' RIGHTS TO CONTINUE BUSINESS

Upon the death, retirement, resignation, expulsion, bankruptcy, withdrawal, or dissolution of a member, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members of the Company shall have the right to continue the business of the Company only upon the vote of a majority in interest of the remaining members.

The power to adopt, alter, amend, or repeal the regulations of the company is vested entirely in the members listed in Article VII.

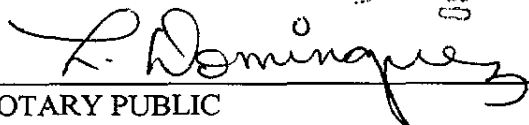
