The undersigned Member adopts the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

**ARTICLE I  
NAME OF COMPANY**

The name of the limited liability company is **ALAN BROWN OF FLORIDA L.C.** (the "Company").

**ARTICLE II  
PERIOD OF DURATION**

The Company's period of duration shall commence on June 1, 2003, and shall terminate on December 31, 2030.

**ARTICLE III  
REGISTERED OFFICE AND AGENT**

**ARTICLE IV  
REQUIREMENTS FOR ADMISSIONS OF ADDITIONAL MEMBERS**

Additional persons may be admitted to the Company as Members and membership interests may be created and issued to these persons upon the approval of holders of at least fifty-one percent (51%) of the remaining Members entitled to vote. The Members entitled to vote are as specified with the Company's Operating Agreement and Regulations.

**ARTICLE V  
DISSOLUTION AND RIGHT TO CONTINUE BUSINESS**

This Company shall be dissolved upon the first to occur of the following:

1. The expiration of the term of the Company;
2. The written consent of fifty-one percent (51%) of the Members entitled to vote as specified within the Company's Operating Agreement and Regulations.
3. The death, retirement, resignation, expulsion, dissolution or bankruptcy of a Member, or any other event which terminates the membership of a Member in the Company, unless within ninety (90) days after such event all of the remaining Members agree in writing to continue the business of the Company.

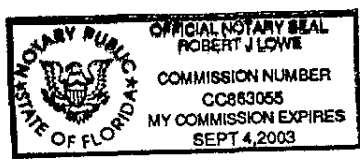
