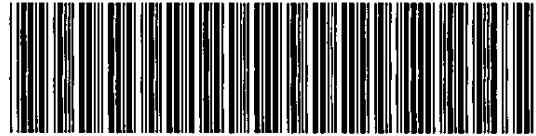

2. The text of the amendment is as follows:
