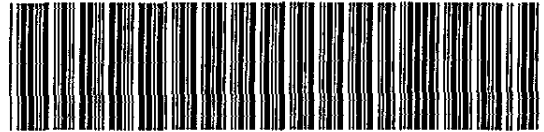

**ARTICLES OF ORGANIZATION
OF

ARTICLE I — Name:

The name of the limited liability company (hereinafter referred to as the "Company") is Trinity DNA Solutions, LLC.

ARTICLE II — Address:

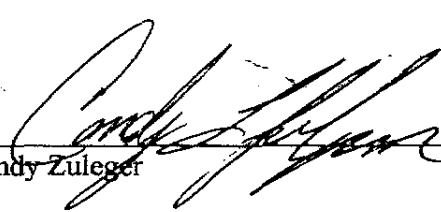
