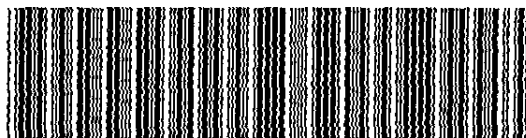



ARTICLES OF ORGANIZATION

OF

HAND PROPERTIES, LLC.

ARTICLE I - NAME

The name of the Florida limited liability company shall be HAND PROPERTIES, LLC.

ARTICLE II - DURATION

The assignee shall merely be entitled to receive the share of profits and other distributions and the allocation of income, gain, loss deduction, credit or similar item to which the assignor was entitled, to the extent assigned.

The management of the Company is reserved to the members. The name and address of each member is:




