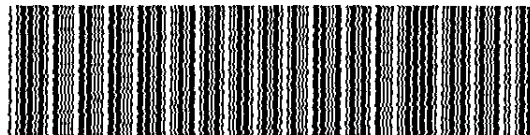

**ARTICLES OF ORGANIZATION  
OF  
SHOPSTUFF, L.L.C.**

The undersigned, being authorized to execute and file these Articles on behalf of the members for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby certify and adopt these Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be **SHOPSTUFF, L.L.C.**

**ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Company shall be **6592 Codell Street, Navarre, Florida 32566.**

**ARTICLE III - DURATION**

The Company shall commence on the date of filing these Articles of Organization with the Florida Department of State and the Company's existence shall be perpetual.

**ARTICLE IV - REGISTERED AGENT**

The power to adopt, alter, amend, or repeal the regulations of the company is vested entirely in the members listed in Article VII.


