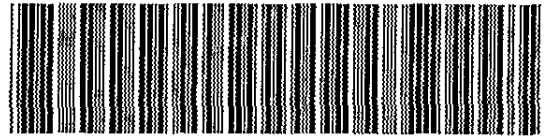

**ARTICLES OF ORGANIZATION  
OF  
COASTAL WATER RESOURCES, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

**ARTICLE I – NAME**

The name of the limited liability company shall be Coastal Water Resources, L.L.C. (the "Company").

**ARTICLE II – ADDRESS**

The mailing address and street address of the initial principal office of the Company shall be 400 North Ashley Plaza • Suite 3000, Tampa, Florida 33602-4331.

**ARTICLE III – REGISTERED AGENT AND REGISTERED OFFICE**

The registered agent of the Company in the State of Florida is Stanford R. Solomon. The registered office of the Company is 400 North Ashley Plaza • Suite 3000, Tampa, Florida 33602-4331.

**ARTICLE IV – DURATION**

The Company shall commence its existence on June 1, 2003. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization.

**ARTICLE V – TERMINATION OF EXISTENCE**

The Company shall be dissolved on the death, bankruptcy or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least two remaining members.

**ARTICLE VI – ADMISSION OF NEW MEMBERS**

No member(s) shall or may be admitted to the Company except upon the unanimous written consent of all the members of the Company. Any newly-admitted member of the Company shall be subject to such terms and conditions as may be determined by all the members. A member may transfer his or her interest in the Company in any manner authorized by the regulations of the Company; provided, however, that the transferee shall have no ability or entitlement to exercise any rights or privileges attendant to membership in the Company or to participate in the management of the business and/or affairs of the Company, unless all members of the Company approve of the proposed transfer by unanimous prior written consent.

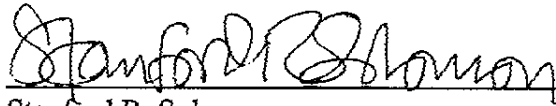

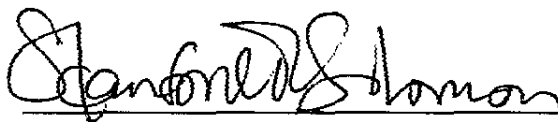
