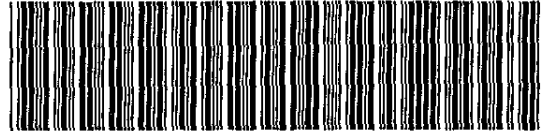

The undersigned individual hereby adopts these Articles of Organization in order to form a professional limited liability company under Chapters 608 and 621, Florida Statutes.

ARTICLE I  
NAME

The name of the professional limited liability company is James L. Ade, P.L. (the "Company").

ARTICLE II  
EXISTENCE, DURATION, AND PURPOSE
