ARTICLES OF ORGANIZATION OF ZHM, LLC

The undersigned, acting as organizer of ZHM, LLC, under the Florida Limited Liability Company Act ("the Act"), adopts the following Articles of Organization for said limited liability company:

ARTICLE I NAME

The name of the limited liability company shall be ZHM, LLC ("the LLC").

ARTICLE II PERIOD OF DURATION

The period of duration shall commence upon the filing of these Articles with the Department of State, and shall be perpetual thereon, unless the LLC is sooner dissolved as provided by these Articles of Organization.

ARTICLE III PURPOSE
