# SECOND AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF THE PINNACLE COMPANIES, LLC

THE PINNACLE COMPANIES, LLC (A Florida Limited Liability Company)

Pursuant to the provisions of Chapter 608 of the Florida Statutes, the undersigned has executed and hereby files the following Second Amended and Restated Articles of Organization for such limited liability company.

The present name of the limited liability company is THE PINNACLE COMPANIES, LLC (the "Company"); the date of filing of its original Articles of Organization with the Secretary of State was June 5, 2003, and the date of filing of the first Articles of Amendment with the Secretary of State was April 18, 2005.

The original Articles of Organization are hereby amended by being deleted in their entirety and restated as follows:
