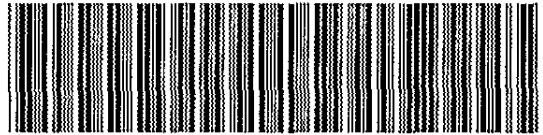

ARTICLES OF ORGANIZATION
OF
R&D ENGLEWOOD MANAGERS, LLC

1. Name. The name of this limited liability company is R&D Englewood Managers, LLC, a Florida limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.
