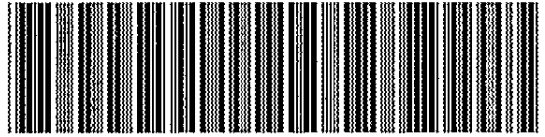

**ARTICLES OF ORGANIZATION
OF
VALUERICH, L.L.C.**

The undersigned hereby forms and establishes a limited liability company under the laws of the State of Florida.

ARTICLE I

The name of this limited liability company is ValueRich, L.L.C. ("Company").

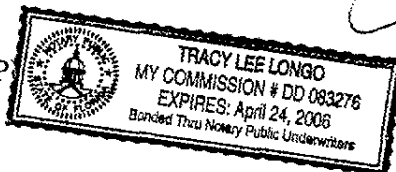
