Pursuant to Sections 608.4227 and 608.4228 of the Florida Limited Liability Company Act, the members shall not be personally liable for any debt, obligation, or liability of the Company regardless of whether the company or its members observe the usual company formalities on requirements relating to the exercise of its Company powers or management.

#### ARTICLE X -Additional Provisions:

The power to adopt, alter, amend, or repeal the operating agreement of the company is vested entirely in the members listed in Article IV of these Articles of Organization as may be amended from time to time.
