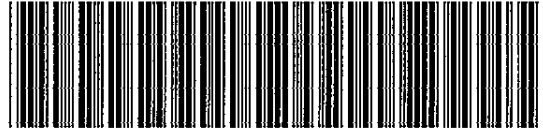

The mailing address and street address of the principal office of the Limited Liability Company is 18401 Murdock Circle, Port Charlotte, Florida 33948-1088.




