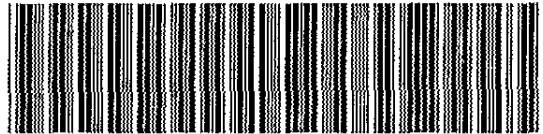

The mailing address and street address of the principal office of the Company is 201 West 23rd Street, Bay #4, Hialeah, Florida 33010.


