ARTICLES OF ORGANIZATION REFRACTORY & CORROSION SERVICES, LLC

ARTICLE I - NAME

AND WALLS The name of this Limited Liability Company is REFRACTORY & CORROSION SERVICES, LLC.

ARTICLE II - ADDRESS AND PRINCIPAL PLACE OF BUSINESS

The mailing address of this Limited Liability Company is: 1401 Chamber Drive, Bartow, Florida 33830, and the principal place of business for this company shall be:1401 Chamber Drive, Bartow, Florida 33830.

ARTICLE III - DURATION
