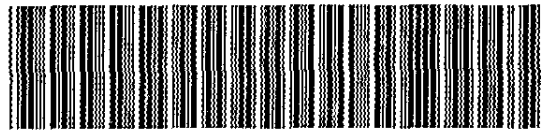


ARTICLE V -- Effective Date
