Articles of Organization of

SNM INVESTMENTS, LLC,

a Florida Limited Liability Company

The undersigned, David R. Stratton, Brenda J. Stratton, Timothy W. Newby, Ann M. Newby and Donna Y. Morrison, desire to form a limited liability company pursuant to the Florida Limited Liability Company Act. As the members of the proposed limited liability company, they do hereby make and file these Articles of Organization, and hereby declare and affirm:

ARTICLE I: Name

The name of the limited liability company ("Company") is SNM INVESTMENTS, LLC, a Florida Limited Liability Company.

ARTICLE II: Street Address and Mailing Address

The street address of the Company's principal office is 6108 Shore Acres Drive, Bradenton, Florida 34209. The mailing address of the Company's principal office is 6108 Shore Acres Drive, Bradenton, Florida 34209.

ARTICLE III: Duration

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.

ARTICLE IV: Registered Agent and Office

The name of the Company's initial registered agent for service of process in the State of Florida is David R. Stratton. The street mailing address is 6108 Shore Acres Drive, Bradenton, Florida 34209.

ARTICLE V: Admission of New Members

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

ARTICLE VI: Pre-emptive Rights

As a function of the agreed value of the initial contributions of the members of this limited liability company, Donna Morrison shall have 33 1/3%, David Stratton and Brenda Stratton, husband and wife, as tenants by the entirety shall have 33 1/3%, and Timothy Newby and Ann Newby, husband and wife, as tenants by the entirety, shall have 33 1/3% interest in the profits and losses of the company. Thereafter, as the members make subsequent contributions to capital or receive distributions of capital, the members shall have "pre-emptive rights" meaning (in the case of this limited liability company) the right to make such subsequent contributions to capital, and to receive distributions from capital in a manner which will allow the members of the limited liability company to maintain their respective percentage in the profits of the company. If, however, any member fails to make his/her contribution of cash, property or services within sixty (60) days after request is made for same, then that member's "pre-emptive" rights shall not be in effect for that particular capital call, but shall remain in effect for any subsequent capital call, but without prejudice to any rights, including the right to specific performance, that the limited liability company may have against such member under the articles of organization or operating agreement or applicable law.

ARTICLE VII: Continuation Provisions

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.

ARTICLE VIII: Additional Provisions

The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the members of the Company. Donna Y. Morrison shall have one vote, David R. Stratton and Brenda J. Stratton, or the survivor of them, shall have one vote, and Timothy Newby and Ann Newby, or the survivor of them, shall have one vote.
