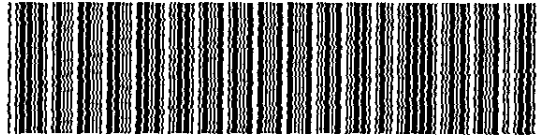

ARTICLE I:

Section 1.01: The name of the Limited Liability Company (LLC) is **Think Hard Enterprises, LLC**.

ARTICLE II:

Section 2.01: The county within this state in which the office of the LLC is to be located is Brevard, Florida.
