

ARTICLES OF ORGANIZATION OF AWESOME SPAS, LLC

The undersigned hereby certifies that he is the Authorized Representative of the Member who is forming a Limited Liability Company under Florida Statutes Chapters 608. The following Articles of Organization are hereby adopted.

ARTICLE I.

The name of the Limited Liability Company shall be Awesome O Spas, LLC.

ARTICLE II. DURATION; EFFECTIVE DATE

This Limited Liability Company shall exist perpetually, commencing as of the date on which these Articles of Organization are filed with the State of Florida Department of State.

ARTICLE III. ADDRESS; PRINCIPAL OFFICE

The mailing address and principal office of the Limited Liability Company is 2442 23rd Street North, St. Petersburg, Florida 33713.

ARTICLE IV. INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The address of the initial registered office of the Limited Liability Company is 1303 North Armenia Avenue, Tampa, FL 33607 and the name of its initial registered agent at such address is Fernando Perez, III.

ARTICLE V. PURPOSE

This Limited Liability Company may engage in any activity or business permitted under the laws of the United States of America and of this State.

ARTICLE VI. VOTING AND NONVOTING

The Members' interests in the Limited Liability Company shall consist of Voting Members and Nonvoting Members, in accordance with the Operating Agreement of the Limited Liability Company.

ARTICLE VII. OPERATING AGREEMENT

The Voting Member(s), by the affirmative vote of the Voting Member(s) who hold a majority of the Voting Interests of the Limited Liability Company shall have the power to adopt, alter, amend, or repeal an Operating Agreement which may contain any provisions for the regulation and management of the affairs of the Limited Liability Company that are not inconsistent with applicable law or these Articles of Organization.

ARTICLE VIII. AMENDMENT

These Articles of Organization may be amended by the affirmative vote of the Voting Member(s) who hold a majority of the Voting Interests of the Limited Liability Company in accordance with the Operating Agreement of the Limited Liability Company.

The undersigned, being the Authorized Representative of the initial Members of the Limited Liability Company, hereby certifies that the foregoing constitutes the Articles of Organization of Awesome Spas, LLC.
