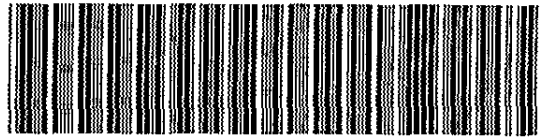



Limited Liability Company Purpose

The initial member-manager and President shall be PAUL KISER.


