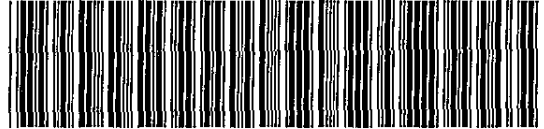

ARTICLE I

NAME

The name of this limited liability company is THE GARBY FAMILY LLC, referred to in these Articles of Organization as the "Company."

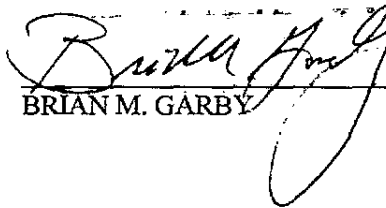
