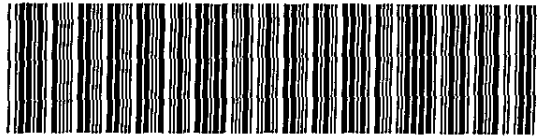

FOR

ARTICLE I - Name

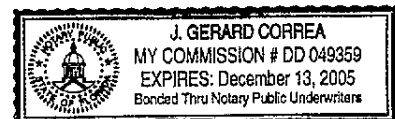
