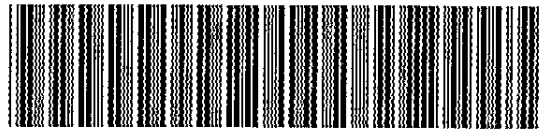

The name of the limited liability company is THE CITY MARKETPLACE LLC(the "Company").

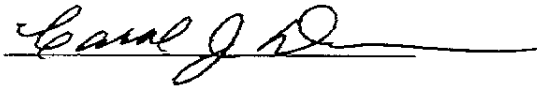

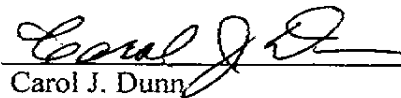

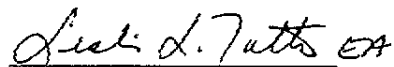
